2017 Energy Efficiency Rebate Form

ELIGIBILITY CRITERIA

- ❖ Equipment must be installed in 2017 and must be installed on cooperative's lines.
- ❖ Rebates are in place through December 31, 2017. Funds are limited so members are encouraged to submit as soon as possible.
- ❖ Rebate not to exceed 50% of the cost of equipment.
- ❖ Additional eligibility criteria may apply. Contact cooperative for details.
- ❖ All documentation listed below must be submitted no later than 3 months after install date of water heater or no later than 3 months after purchase date of flow restrictor(s).
 - ✓ This Rebate Form
 - ✓ A copy of your receipt or invoice for each item purchased
 - ✓ For water heaters, include documentation showing the equipment has been installed
