<b>Single Phase Time of Day Rate</b>	7.01C	8	1/1/2023	12/28/2022

**Applicability**

Applicable to all consumers requiring single-phase service for all uses subject to the established policies, rules and regulations of the Cooperative.

**Character of Service**

Single phase, 60 cycles, at available secondary voltages.

**Monthly Rate**

- Monthly Service Availability Charge - \$46.45 /month
- Additional Monthly Facility Charge - \$1.00 per KVA of required transformer capacity in excess of 25 KVA
- All kilowatt-hours (kWhs) used during the following “peak hours” shall be billed at the rates indicated:
  - between 11:00 AM and 7:00 PM, weekdays only, during the months of June through August, @ \$0.30 per kWh,
  - between 4:00 PM and 10:00 PM, weekdays only, during the months of December through February, @ \$0.35 per kWh
  - and, between the hours of 5:00 PM to 8 PM, weekdays only, during all other months @ \$0.30 per kWh
- All kWhs used during “off-peak hours” (including weekends and holidays\*) during the months of:
  - June through August @ \$0.0906 per kWh
  - All other months @ \$0.0756 per kWh
- The energy charges shall be “unbundled” on the bills delivered to the members for monthly electric use, to show the approximate amount of wholesale and local costs.

**Minimum Monthly Charge**

The minimum monthly charge under the above rate shall be the Monthly Facility Charge as indicated above. The minimum applies 12 months per year even when disconnected. When service is reconnected a bill will be rendered for months not billed. This applies to any service disconnected for up to one year. If meter is removed, continued maintenance of electric service and/or billing under Policy 7.06, Idle Services may apply.

**Power Cost Adjustment (PCA)**

If the rate under which the Cooperative purchases power at wholesale is adjusted in accordance with provisions in the wholesale contract, a PCA may be added to the monthly bill under Board Policy No. 7.01(D).

**Taxes**

Any taxes, based on revenue from the sale of electric energy which the cooperative is required to collect, will be itemized on the bills and are subject to the same terms of payment as are the energy charges.

**Terms of Payment**

Bills shall be mailed to members during the first week of each month and are due on the 20<sup>th</sup> day of the same month. If payment is not made on or before the due date printed on the statement a 1½% late payment charge may be assessed on the unpaid balance.
