Three Phase Power Rate	7.03	19	1/1/2023	12/28/2023

## **Availability**

Available for all three-phase customers served through one meter. All subject to the established policies, rules and regulations of the Cooperative and execution of an Electric Service Agreement between the Cooperative and the Customer.

### **Character of Service**

Three-phase, 60 Hertz, at available secondary voltages

#### Rate

(a) Service Availability Charge \$71.85/month

(b) Demand Charge \$10.00 per kW September thru May

\$12.00 per KW June thru August

(c) Power Factor Charge \$0.25 per kVAR (at the option of the Cooperative)

(d) Energy Charge \$0.0731 per kWh September thru May

\$0.0881 per kWh June thru August

The energy charges shall be "unbundled" on the bills delivered to the members for monthly electric use, to show the approximate amount of wholesale and local costs.

(e) Power Cost Adjustment As authorized by the Board of Directors
(f) Taxes Plus, applicable sales tax as appropriate.

## **Billing Demand**

The billing demand shall be the maximum 15-minute integrated demand, with 5-minute sub-intervals, in kilowatts (kW) recorded during the current month.

## **Minimum Monthly Charge**

The minimum monthly charge under the above rate shall be equal to the Facility Charge indicated above, or as indicated in a signed Electric Service Agreement. The minimum applies 12 months per year even when disconnected. When service is reconnected a bill will be rendered for months not billed. This applies to service disconnected for up to one year. If meter is removed, continued maintenance of electric service and/or billing under Policy 7.06, Idle Services may apply.

## **Power Factor Charge**

The reactive billing demand will be the average amount of lagging kVAR coincident with the twelve (12) monthly maximum demand readings.

## **Power Cost Adjustment (PCA)**

If the rate under which the Cooperative purchases power at wholesale is adjusted in accordance with provisions in the wholesale contract, a PCA may be added to the monthly bill under Board Policy No. 7.01(D).

Any taxes, based on revenue from the sale of electric energy which the Cooperative is required to collect, will be itemized on the bills and are subject to the same terms of payment as are the energy charges.

# **Terms of Payment**

Bills shall be mailed to members during the first week of each month and are due on the 20th day of the same month. If payment is not made on or before the due date printed on the statement a 1½% late payment charge may be assessed on the unpaid balance.
