**Availability:**

Available to any member of the Cooperative employing electricity as a source of heating energy in their residence, commercial building, seasonal dwelling or cabin, milkhouse or other buildings, with a minimum of 2,500 watts, or 2.5 KW, which can be controlled off the peak demand period. The electric heating shall be subject to the load management program of Dairyland Power Cooperative. The system shall be wired direct, metered separately, and the meter shall be installed on the outside wall, allowing availability to the Cooperative at all times. Service is further subject to the policies, rules, and regulations of the Cooperative.

**Type of Service:**

Single-phase, 60 cycle, at available secondary voltage.

**Rate:**

Service Availability Charge - \$5.00 /month

WINTER (September-May) \$0.0656 per kWh, metered separately, plus applicable sales tax.

SUMMER (June-August) \$ 0.1011 per kWh, metered separately, plus applicable sales tax.

The energy charges shall be “unbundled” on the bills delivered to the members for monthly electric use, to show the appropriate amount of wholesale and local costs.

**Alternative Heating System:**

Each member applying for this rate for controlled electric heating shall have a standby or alternative heating system available for heating during the control period under the load management system. The Cooperative shall not be liable for any damage or harm caused by not having an alternative heating system available during the control period.

**Effective:**

The rate above shall apply at the approval of inspection by Cooperative personnel for the installation of electric heat, standby heating system, wiring, radio receiver and control specifications.

**Minimum Monthly Charge**

The minimum monthly charge under the above rate shall be equal to the Monthly Facility Charge shown above. The minimum applies 12 months per year even when disconnected. When service is

reconnected, a bill will be rendered for months not billed. This applies to service disconnected for up to one year. If the meter is removed, continued maintenance of electric service and/or billing under Policy 7.06, Idle Services may apply.

**Power Cost Adjustment (PCA)**

If the rate under which the Cooperative purchases power at wholesale is adjusted in accordance with provisions in the wholesale contract, a PCA may be added to the monthly bill under Board Policy No. 7.01(D).

**Taxes**

Any taxes, based on revenue from the sale of electric energy which the Cooperative is required to collect, will be itemized on the bills and are subject to the same terms of payment as are the energy charges.

**Terms of Payment**

Bills shall be mailed to members during the first week of each month and are due on the 20<sup>th</sup> day of the same month. If payment is not made on or before the due date printed on the statement a 1½% late payment charge may be assessed on the unpaid balance.
