President & CEO retires after 37-year career with Taylor Electric

The new year will bring plenty of change to Taylor Electric Cooperative with the retirement of President & CEO Mike Schaefer. Mike has been employed with Taylor Electric

Cooperative since 1982, when he started as office manager. In 1992, Mike was promoted to president & CEO. He will retire in early January 2020.

During his 37-year career at the cooperative, Mike steered the co-op through many challenges and rewarding changes. He was very involved in the office and shop additions and remodeling. From self-read meters to automatic reading meters to community solar and broadband research, he ensured the cooperative kept on trend with the ever-changing ways of the electric industry. Mike helped to implement the innovative rate designs such as prepaid metering and time-of-day meters. Under Mike's leadership all federal loans were paid off in 1996.

Mike's dedication to cooperatives is evident from his involvement in many groups within the cooperative network. He served as a manager-director on the board of the Wisconsin Electric Cooperative Association from 2003–2009, and represented Wisconsin electric cooperatives on the Wisconsin Federation of Cooperatives' board from 1994–2005. He has served on the board of the Taylor County Association of Cooperatives since 1992, also serving as the treasurer. He has been a member of the Dairyland Managers Association and the Electric Cooperative Managers of Wisconsin since 1992, including service in all officer positions for both groups.

Community service is also very important to Mike. He served on the Memorial Hospital Foundation Board from 1995–2003, including one term as president, and on the Memorial Member Association Board from 2009–2018. Mike is a founding and current board member of Medford Junior Achievement, which he's served since 2002. He was also a volunteer fourth-grade instructor for the program for seven years.

Mike has been a Kiwanis member since 2005, and has earned the following honors: club president 2012–

DIRECTORS TO BE ELECTED AT APRIL 4 ANNUAL MEETING

Nominating Committee seeking candidates

Taylor Electric Cooperative's 84th annual meeting will be held at the Stetsonville Centennial Center in Stetsonville on Saturday, April 4, 2020. One of the most important duties of the members at this meeting will be to elect members to fill two seats on the board of directors.

The Bylaw provision for nominating a member to serve on the board is as follows:

(Article V) Section 3. Nomination and Election of Directors. It shall be the duty of the Board of Directors to appoint a nominating committee in time to allow the committee to meet at least forty-five (45) days before the date of the annual meeting of the members, at which directors are to be elected. The nominating committee shall consist of three members. The committee chairman shall present the committee's nominations at the annual meeting.

Nominations may also be made by petition signed by not less than 25 members delivered to the Cooperative's head-quarters not less than 7 days prior to the annual meeting. Election shall be by majority vote for each director position. In the event no candidate receives a majority of the votes cast for a position, the candidate receiving the fewest votes shall be dropped from nomination on each successive ballot until one candidate receives a majority of the votes cast.

Please contact any of these Nominating Committee members by the end of January if you are interested in being nominated for a seat on the board.

At the 2020 annual meeting, there will be elections for

two board seats: the seats currently held by Patricia Waldhart and Chuck Zenner. Directors are eligible to serve up to five three-year terms. Pat and Chuck are eligible for re-election.

To be on the ballot for elec-

tion to the board, a member needs to be nominated by the Nominating Committee, or be nominated by petition, which involves getting signatures of not less than 25 members and delivering that nomination petition to the co-op not less than seven days prior to the annual meeting (by March 27, 2020, for the upcoming annual meeting.)

CONGRATULATIONS ON YOUR RETIREMENT, KEVIN!

Congratulations to Kevin Comstock, who retired at the end of December as line superintendent after 13 years of service at Taylor Electric Cooperative, with a total of almost 34 years in the rural electrification program.

After growing up on a farm and then going to line school, Kevin knew he wanted to work for a rural electric cooperative. He began his career at Columbus Electric Cooperative in 1986, the same year he met his future wife, Sandy. In 1987, he started working as a second-year apprentice with Adams-Columbia Electric Cooperative after Columbus merged with Adams-Marquette Electric Cooperative. He got married in 1988 and later bought a house in the country south of Montello.

In 1990, Kevin became a journeyman lineman while working between the Briggsville and Montello outposts for ACEC. He was transferred to the Wautoma Service Center in 1991 after the co-op's merger with Waushara REC. In 1994, he transferred to ACEC's new service center in Pardeeville, 10 miles from where he grew up on the family farm. He was promoted to the operations supervisor of the Pardeeville shop in

2002 and held that position for four years.

Kevin and Sandy had always wanted to live in northern Wisconsin and the opportunity arose in 2006. Around Christmas that year they moved to Medford, where Kevin started his new position as line superintendent at Taylor Electric Cooperative.

As line superintendent, Kevin was able to engineer, design, and stake new overhead and underground lines for safe and efficient operation of the utility system. With many hours of service and extreme dedication, organized work processes, and crews and contractors that had a great sense of teamwork, they replaced over 200 miles of line to provide a much more reliable electrical distribution system and greatly reduce the average outage time for Taylor Electric's members. Kevin also enjoyed meeting with members to discuss options and costs for new services and upgrades.

He also played a large part in designing and coordinating the new shop and pole shed addition in 2013 that improved efficiency and resulted in savings in heating costs.

Kevin says he is thankful to have had

the opportunity to work at Taylor Electric and felt privileged to work with great employees, directors, vendors, and members. He said he also feels fortunate



to have worked with linemen with a great work ethic and safety awareness in a very dangerous industry.

Kevin says he has enjoyed his career and will miss many things including the good friends he made in the industry. However, after 34 years he is looking forward to retirement. He and Sandy are ready to enjoy their freedom to do some overdue traveling, spend more time with family and friends, snowmobile, bike trails, and get back to hunting and fishing as well as complete a few outdoor projects at home.
