## Policy change for member-owned yard lights

In the past, our crews and trucks have been available to repair member-owned lights as a fee-based service. We are discontinuing this service for a few reasons. First and foremost, this work is regulated and technicians must be licensed electricians to perform. Second, with many lights controlled by switches or behind breakers inside the house, we were unable to make the repairs without an appointment when the member was at home. Lastly, the many variations of lights and equipment required a larger variety of parts than we normally stock. We apologize for any inconvenience to the members that we have helped in the past. Please contact one of the local electricians to assist with light repairs. We will also no longer sell the repair parts for existing lights as we transition to all LED lighting for TEC owned/member rented lights.

## Board Report – November 2022

- Approved October disbursements totaling \$424,623. 11 new member applications, and October 2022 construction in the amount of \$153,728.
- Reviewed financial results for October with \$451,116 Operating Margins and \$801,219 Total Margins year to date.
- There were 12 outages in October, with an average YTD outage time per meter of 0.6149 hours.
- Four applications for discounted early retirement of capital credits to estates were approved with total capital credits of \$5,554 to be paid out at the net present value of \$2,101.
- 26 delinquent accounts were processed for collection following the November 20th due date. The total amount owing on these accounts is \$8,591.
- Other topics covered included upcoming rate changes, power cost adjustments, DPC budget and rates, 5 policies, absentee balloting, bylaw changes, and upcoming local and national meetings.


#### RATE ADJUSTMENT REMINDER (Billing starting in February 2023)

This is a reminder of the upcoming January rate increase. There will be no change in the energy pricing; only the base fee will be adjusted to reflect changes in the fixed costs of operation of the cooperative.

Single phase base fee will increase to \$44.95/month, Single phase time-of-day to \$46.45/month, Three phase to \$71.85/month, and Three-phase peak alert to \$134.85/month.

# Downed and Dangerous

If you see a downed power line, always assume it is energized and dangerous. Avoid going near it or anything in contact with the power line.



Downed power lines can energize the ground up to **35** ft. away – so keep your distance.

Never drive over a downed line or through water that is touching the line.

If you see a downed line, notify the local authorities immediately.



Never try to move a downed power line, even if you think the line is deenergized or if you're using a non-conductive item – this will not prevent injury or death!
